Amended FY 2022 Transportation Allotments

- Individual letters were distributed to transportation directors and finance officers.
- Cash of \$188,001,658– this is not bus bonds
- **\$153,928,170 for bus replacement funds**
- Grant #821
- General Ledger Fund 100, Program Code 2412
- Funds must be spent by June 30, 2025

REMINDER

Amended FY 2022 Transportation Allotments

- \$34,071,830 – safety incentives – Grant #822, General Ledger Program Code 2413
- \$5,000,000 – alternative fuel incentives – Grant #824, General Ledger Program Code 2414
- Plan on distributing these funds through an application process
- Funding is intended to be a three-year appropriation – spent by June 30, 2025

REMINDER

Amended FY 2023 Budget: School Security Grants

- Email to Superintendents and Finance Officers on April 18, 2023
- \$115,700,00 funded state-wide; \$50,000 per school
- One-time purchase of goods or services within this scope
- Excludes ongoing expenses such as salaries, rent, or vehicles
- Invoice must be dated on or after March 10, 2023
- GAORS Invoice Application utilized
- No reimbursements were to be issued until after June 30, 2023
- Requests for reimbursement must be submitted no later than March 1, 2024
- Fund 100, Revenue Source 3800, Function Code 2600, Program Code 1695
- Funding expired June 30, 2024, with some exceptions approved.

Amended FY 25 Budget

- Enrollment Growth: \$114,282,588
- Increase of State Charter Supplement Formula Grant, Local Charter Supplement Formula Grant, and Charter System Grant, as well as increase in Training and Experience for Charter Schools: \$15,896,009
- Increase in Special Needs Scholarship: \$12,304,103

Amended FY 25 Budget

- Local Five Mill Share Adjusted
 - 3 state charter schools included in the original calculation were removed.
 - The LFMS Cap was not removed and the overall allotment was not changed for the total amount removed.
 - The LFMS that was originally allotted to the 3 state charters that closed was prorated and redistributed to the remaining school districts.
 - Amount of LFMS for each LEA is still less than the total amount calculated due to the cap.

Amended FY 25 Budget

- Additional School Security Grant
- \$50,000,000
- Fund 100, Revenue Source 3800, Program Code 1695
- Will utilize the Consolidated Application for budget approval and Invoice Application for reimbursement approval.
- Period initially from March 6, 2025 – June 30, 2026
- NEW ALLOWABILITY: Are vehicles an allowable expense?
- Yes. Law enforcement specific vehicles are an allowable expense as well as the accessories (radio, decals, lights, etc.). School Police Departments shall follow their internal procurement process to obtain the vehicle and equipment. For those districts that contract with local law enforcement (Sheriff's Office or Municipal Police), the price of the vehicle may be included in the contracted cost. Specialized tactical vehicles are not permitted.

Initial FY 2026 Budget – HB 68

Department of Community Health

Recognize an increase in formula funds in the Department of Education... to reflect an increase in the employer healthcare contribution per-member per-month rate for certified school employees to \$1,885 effective July 1, 2025.

Increase the employer health care contribution per-member per –month for non-certified school employees to match the PMPM for certified school employees, effective July 1, 2025.

FY 26 Bus Driver Base Salary Schedule

- FY 2026 – No Change from FY 2025
 - Salary - \$10,821.56
 - Social Security - \$827.42 (7.65%)
 - Sick Leave - \$125
 - Requirement Medical Examination - \$30
 - Total - \$11,803.98

FY 26 Nursing Salary Schedule

- Salary for each RN earned in formula - \$55,609
 - Earn 1 RN for every 4,500 elementary FTE, 1 RN for every 9,000 other FTE
- Salary for each LPN earned in formula - \$39,544
 - Earn 1 LPN for every 900 elementary FTE, 1 LPN for every 1,800 other FTE
- TRS rate of 21.91% applied
- Medicare rate of 1.45% applied
- (Note: Does not mean you have to pay at that rate)
- Salary is earned based on FTEs reported. You earn positions. (O.C.G.A. §20-2-186)
- Minimum grant \$45,000 for traditional school districts and \$20,000 for state charter schools
- State support is 50% of the calculated amount based on FTEs

FY 2026 Budget Considerations – Pending Governor Approval

- TRS Employer rate is increasing to 21.91% from 20.78%
- SHBP certified employer rate is increasing to \$1,885 from \$1,760
- These increases affect the Salaries/Benefits Payable calculation and should be considered when posted as of June 30th.
- Example: To calculate the increase in the benefit expense, run the May payroll, save a copy to excel, and change the deduction for the SHBP and the TRS within excel. Use the updated balances to upload the payables for July and August in the Financial System.

Teacher Retirement System Rates

- Employer Rates
 - FY 2024 – 19.98%
 - FY 2025 – 20.78%
 - FY 2026 – 21.91%
- Employee Rates
 - FY 2024 – 6%
 - FY 2025 – 6%
 - FY 2026 – 6%

FY 25 School Security Grants

- School Security Grants - \$108,905,000
 - *Provide funds to establish school security grants for safety infrastructure and POST certified personnel*
- Email sent to Superintendents on May 21, 2024
- \$47,124 per school
- Statewide 2,311 schools, including GNETS facilities
- RESAs awarded funding for 1 GNETS school if they are the fiscal agent.
- Funding will be distributed monthly through the GAORS system.
- No budget required; no completion report required.

FY 25 School Security Grants

Amended FY 2025 Budget includes the following language:

The Department of Education shall provide an annual report to the Governor's Office of Planning and Budget, the House Budget and Research Office and the Senate Budget and Evaluation Office regarding the utilization of the \$108,905,000 base funding for school security by local education agencies. Reports shall be provided annually on October 1, beginning October 1, 2025.

FY 25 School Security Grants

Webinar in partnership with the Office of Whole Child, School Safety Division tentatively scheduled for Wednesday, May 21, 2025 at 10 am.

Be prepared to answer questions such as these:

- Were PTSOs employed for each school facility in the school system?
- Were the PTSOs full-time employees or contracted?
- What was the total amount expended for salaries/benefits of PTSOs?
- Did the LEA have any unspent funds remaining at June 30th?
- How will the unspent funds be utilized?

HB 92 – Opt Out of Base Year Homestead Exemption – Signed 4.1.25

- In order for HB 581 Opt Out Decision to remain effective for tax years 2027 (FY 2028) and after:
 - The same procedures and hearings must be repeated.
 - Resolution filed with the Secretary of State by March 1, 2027.
- Exempts qualifying construction materials used in capital outlay projects for educational purposes from local sales and use tax paid. Only allowable for those school systems with a base year value homestead exemption in place.

HB 235 – GA Support for Living Donors – Signed 4.28.25

- Must provide leave for up to 7 days for bone marrow donation.
- Must provide leave for up to 30 days for the purpose of organ donation for transplantation

HB 268 – Student Advocacy – Signed

4.28.25

Amends various code sections relating to “juvenile code, elementary and secondary education, and emergency management, respectively, so as to provide for the safety, health, and well-being of students and school communities; to require public schools to implement a mobile panic alert system capable of connecting disparate emergency services technologies to ensure real-time coordination between multiple state and local first responder agencies in the event of a school security emergency....”

The FY 2026 Initial Budget includes \$6,963,875 in additional funding for a qualified student advocacy specialist. Draft allocation methodology:

- 0 to 18,000 FTEs = 1 student advocacy specialist
- 18,001 to 36,000 FTEs = 2 student advocacy specialists
- > 36,000 FTEs = 3 student advocacy specialists

HB 307 – Dyslexia – Signed 4.28.25

- Provides for the Georgia Literacy Coach Coordinating Committee within the Governor's Office of Student Achievement (GOSA).
- Requires the State Board of Education to approve an MOU between the GA Literacy Council and GaDOE that includes a list of 5 universal reading screeners, one of which shall be a free universal reading screener, for use by public schools and local school systems as part of their comprehensive literacy programs which meet certain criteria.
- Funding will not be distributed in full in August as it has been the past few years.
- Email sent to Superintendents on April 30th Re: Dyslexia Screening

HB 371 – Capital Outlay Funding

Starting with FY 2027, increasing the authorized level of funding for Capital Outlay Grants from \$300 million to \$375 million.

SB 44 – Equalization

- Reduces the required actual or equivalent mill rate to 10 mills, instead of 14 mills. Effective July 1, 2025.
- Calendar year 2025 mill rate, FY 2026.
- Affects the FY 2028 initial calculation.
- Requires a reduction of the equalization grant if the mill is dropped below 10 mills in the year of the grant.
 - Reduction is set at 75% of the initial allotment.
 - Reduction would be applied at the midterm.
- May affect the mid-term FY 2026 equalization.

SB 82 – Local Charter School Authorization and Support – Signed 4.28.25

- Includes certain reporting requirements if a local board of education denies a local charter petition. The reporting requirements will be published by the Office of Charter School Compliance.
- Denial of local charter petitions that are subsequently approved by the State Charter Schools Commission could result in a loss of the school system's charter or strategic waiver contract.
- The state board may require training for authorizers.

SB 93 – Georgia Literacy Act

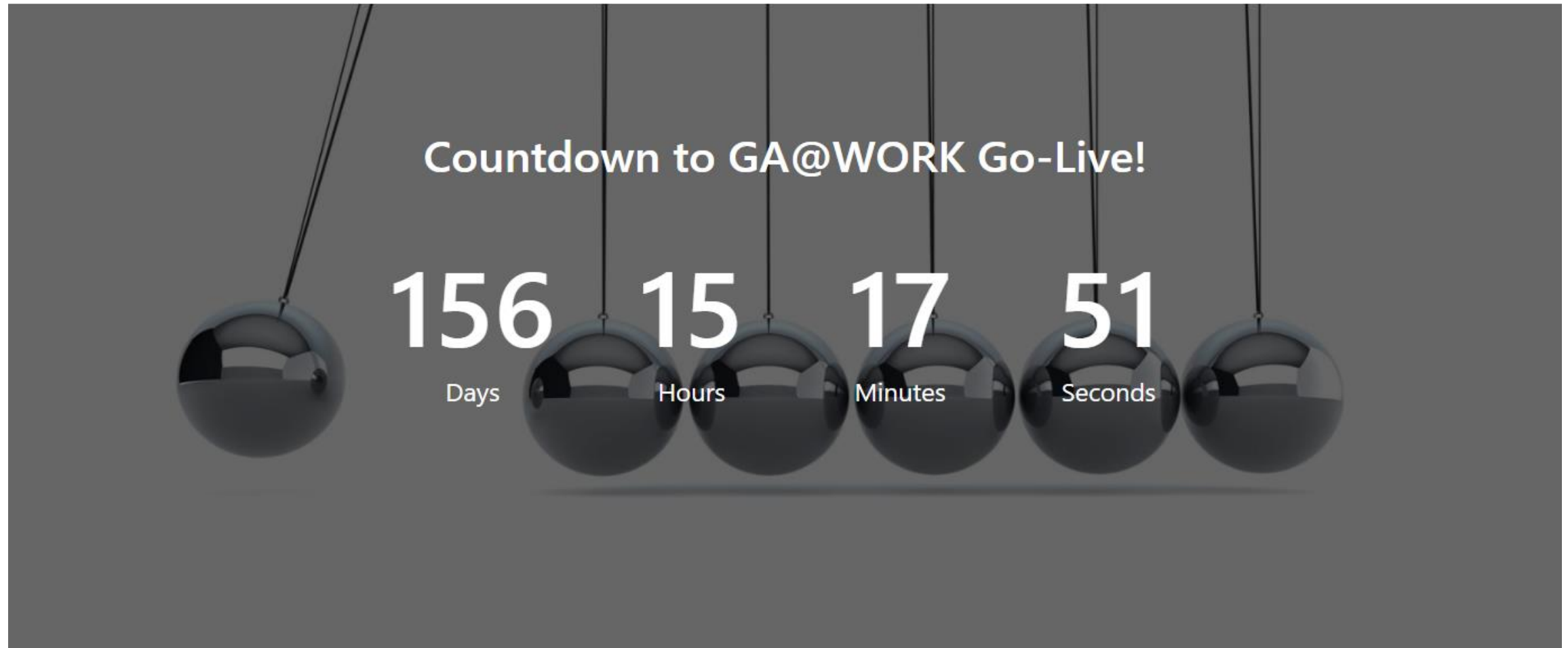
- The Professional Standards Commission is required to adopt rules that establish the criteria for core curricula for state approved education prep programs.
- The Initial FY 2026 Budget includes \$18,480,000 for 116 RESA-based literacy coaches to improve literacy outcomes in grades K-5.

Updates to the Chart of Accounts

Code Relationship Change

- Program Code 1613 – State Dyslexia Screening Grant – only used with Function 2100 – Pupil Services
- Program Codes 1670 and 1695 – use Function 2660, NOT 2600.
- Object Code 116 – Stipends – only used for stipends associated with professional development or continuing education courses. Function Code 2213
- Object Code 199 – All Other Stipends/Supplements – various function codes.

GA@Work – Statewide Software Conversion

Only one payment will be processed monthly through January 2026.

This affects all grants that are processed through the Consolidated Application, including Bond Grants.

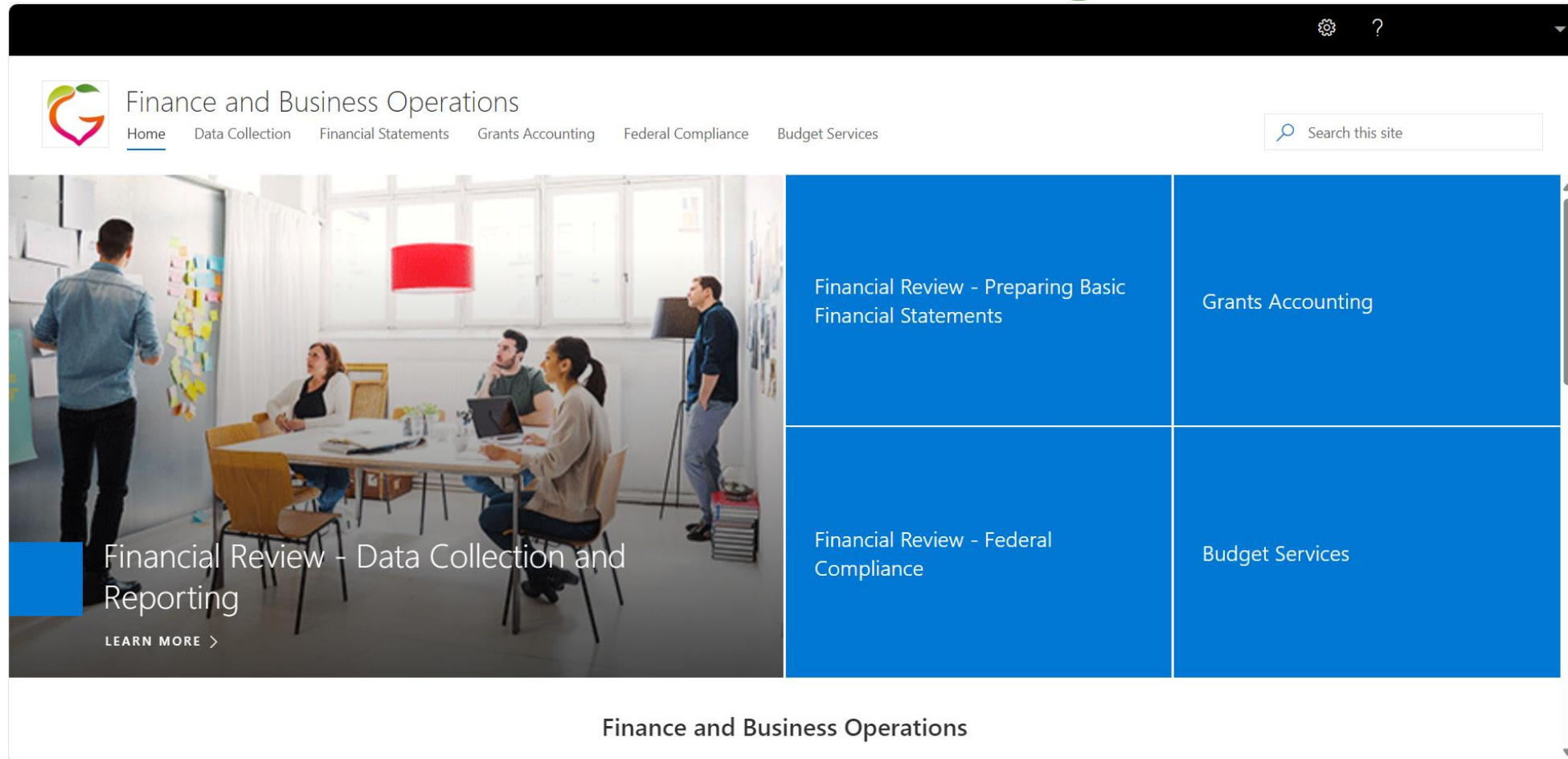

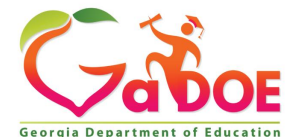

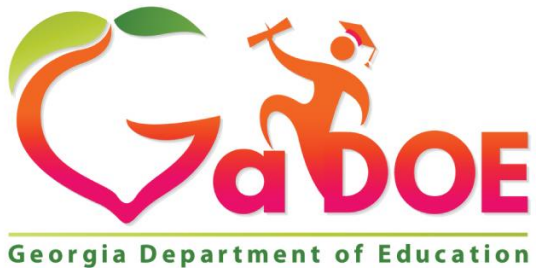
